- vi) The contractor must have Batching Plant, Transit Mixer, Ply / Steel Shuttering, Scaffoldings, Excavator, Jack Hammer, Grader and Portable Mixer Machine available (the machinery / equipment may be physically verified by the committee)
- vii) Annual turnover of at least 148.00 Million or above for the last three financial years with Audit Report from ICAP Certified Audit Firm.
- viii) Bio data of Engineering and Technical staff working with the firm along with attested CVs showing employment with the firm, their salary slips and evidence of Income Tax Deduction (last 6 months). Civil & Electrical Engineers employment with the firm along with same reflected in PEC License.
- ix) The contractor must have following Personnel Capabilities:

#### For Key Positions (Academic Qualifications):

- a. At least 01 Civil Engineers having B.E (Civil) degree
- b. At least 01 Electrical Engineer having B.E (Electrical) degree.

#### For Key Positions (Experience):

- a. Worked in at least 2 or more similar projects
- b. Must have experience of at least 5 years
