



- 3. The tenderers are required to comply with all the clauses mentioned in the terms & conditions of the tender documents and any deviation will forbid them for competing in the tender. The supply of the Dietary items shall be in conformity with the recommended specifications. Bidder will be bound to provide after sales & service facility till the period of equipment warranty.
