- ii) At least 03 work having same specifications and nature having equal or more cost <u>OR</u> quantum (in terms of quantities) completed during past three years duly supported with completion certificate, certificate copies of Detail Working Estimate and SPPRA ID's showing Bid evaluation report.
- Bio data of Engineering and Technical staff working with the firm.
- iv) Annual turnover atleast twice per annum, the estimated cost of the work applied, in last 3 years (turnover will be evaluated from annual returns and Audit Reports)
- Annual Audited reports of last three years from (ICAP) registered audit firm. Audit report issued other than (ICAP) registered audit firms will not be accepted.
- vi) List of Machinery and equipment available with documentary evidence of its ownership / rented.
- vii) Certificate of Bank showing credit worthiness of atleast 15% (average balance per year for the last 03 years) of the estimated cost of work along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for last three years and recent bank certificate must be attached showing available balance.
- viii) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- ix) Annual Income Tax returns of last three years.
- x) Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate (with Active Status).

xi) Each page of the Technical proposal must be numbered and attested by the owner of firm / company alongwith its stamp

Financial bids / proposals of technically un-qualified contractors shall be returned to them un-opened.
- 7. The CD-Rs of the technically responsive bidders will be returned back after the issuance of work order to the successful bidder.
- 8. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening bids will be submitted and opened on next working day on same schedule.
- Joint Venture will not be allowed.
