- vi) Annual turnover must be equal as per estimated cost or above for the last three years.
- vii) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- viii) The 2% Earnest money shall be submitted in shape of Call Deposit / Pay Order/ Demand Draft from any scheduled Bank of Pakistan in favour of Executive Engineer, Provincial Buildings Division-I, Karachi.
