02. Eligibility / Mandatory.

- i) Valid Registration Certificate upto December 2020 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against each work.
- ii) Atleast 03 works of same specifications and nature of equivalent or more cost completed during past three years, duly supported with completion certificate (Works/BER hosted on SPPRA web site).
- iii) Bio data of Engineering and Technical staff working with the firm.
- iv) Annual turnover atleast twice per annum, the estimated cost of the work applied, in last 3 years.
- v) Annual audited reports of last three years from registered audit firm.
- vi) List of Machinery and equipment available with documentary evidence of its ownership.
- vii) Documentary evidence showing the contractor / firm owns /Rented an Asphalt Plant along with its related machinery such as Tandom, PTR and Paver machine. (Applicable only on Asphalt related works).
- viii) Certificate of Bank showing credit worthiness of atleast 20% of the estimated cost of work applied along with Bank Statement.
- ix) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- x) Annual Income Tax returns of last three years.
- xi) Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last 3 years.

03. Method of Procurement (Single Stage two envelops) Must contain 02 separate sealed envelops for technical & financial otherwise such tender will not be entertained.

04. Bidding / Tender Documents.

1. Contract documents and other terms and conditions can be seen and blank tenders can be issued or downloaded from the official website of SPPRA i.e "ppms.pprasingh.gov.pk". The tenders fee amount to PK Rs. 5000/- and the bid security @ 5% as mentioned above against each work **in the shape of call deposit only from any scheduled bank of Pakistan in favour of the Executive Engineer, Local Government Project Hyderabad on account of (Name of firm)** should be attached with the Bid / Tenders, otherwise such tenders will not be entertained.
2. The tender will be opened in presence of the Procurement Committee/ participating contractors /firms and their authorized representatives.
3. Bid shall comprise of Single Package containing two separate envelops. Each envelops shall contain separately the **FINANCIAL PROPOSAL** and the **TECHNICAL PROPOSAL**. (One original + One copy extra) mentioned name of firm/company and applied work & Technical & Financial.
4. **TECHNICAL PROPOSAL** opened shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bids / proposals of technically un-qualified contractors shall be returned to them un-opened.
5. The CD-R's of the technically qualified bidders will be returned back after the issuance of work order to the successful bidder.

6. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening, bids will be submitted and opened on next working day on same schedule.
7. Joint Venture will not be allowed.
8. Affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus /Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
9. Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner for participation.
10. In case of Firm, give full particulars of Directors / Proprietors or other connected documents along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished.
11. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work of any Government Department / organization.
12. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
13. The tenders should be submitted alongwith the above required documentation / information, if such lack the tender will not be considered by the procurement committee and no excuse will be considered.
