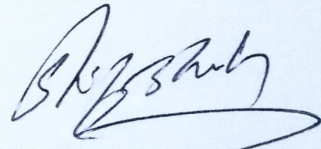

4	The earnest money equal to 5% schedule items in shape of pay order from any scheduled bank in favor district council Karachi must be enclosed with tender documents otherwise the tender will be rejected.		
5	The contractor must mention their complete and correct present/postal address in tender documents and quote the rates both in words and figures incomplete/conditional tenders will be not accepted.		
6	If any fake documents are found then the tender is liable to be rejected-cancelled without any compensation, but penalty will be imposed as per rules.		
7	Canvassing in connection of tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will liable for rejection.		
8	All the tenders will be dropped on as per above schedule up to 2:30pm will be opened by the procurement committee, in office of the District Engineer, DCK situated at old Gadap Town office at Dumba Goth Superhighway Karachi at 3:00 pm in presence of such contractors/parties/firms/bidders who wish to be present.
