- In case the tenders are cancelled / rejected or un-responded, the next date of issuing upto **13/01/2025 @ 1:00 PM** and received back on **14/01/2025 @ 1:00 PM** and will be opened by Procurement Committee on same date at **2:00 PM**.
- 5% Earnest money** of the tender amount in the shape of call deposit / pay order / demand draft from any scheduled bank of Pakistan in favour of **Executive Engineer (Dev.) Public Health Engineering Division Shaheed Benazirabad** should be attached with the bids / tenders.
- Valid Registration Certificate from Pakistan Engineering Council in relevant category and discipline (CE-09, CE-10) except for works costing upto 4.0 million.
- Registration with income tax Department (NTN Copy) and Sindh Revenue Board (Sale Tax Registration) and copy of CNIC of owners / proprietors.

(Eligibility / Qualification Criteria)

- a. Experience in similar nature of work(s) executed during last five years:
 - At least on similar nature of work having minimum cost 80% of the estimated cost of the work; or
 - At least two similar nature of works each having minimum cost 50% of the estimated cost.

- b. Average Annual Financial Turn-over not less than equivalent cost of the scheme/project during last five years.
 - c. Details of equipments / Staff (if any)
 - d. Registration with income tax department (NTN Copy)
 - e. Sindh Revenue Board (Sale Tax Registration) Copy
 - f. Copy of CNIC (Owners / Proprietors)
 - g. The instructions to bidders, bidding data, conditions of contract, contract data mentioned in SBD are applicable.
 - h. Affidavit that the firm is not blacklisted by any procurement agency.
 - i. Affidavit that the given information, documents and data is absolutely true and correct.
 - j. Affidavit that the firm shall be responsible for defect liability in respect of work for period of 6 months from the date of completion of work (period of defect liability).
8. In case of force majeure on submission / opening date and time or if Government declares Holiday the tender shall be submitted / opened on the next working day at the same time and venue.
9. Conditional tenders will not be entertained.
10. The lowest evaluated bidder will deposit remaining amount of 10% as performance security in terms of Rule-39 of SPP Rules-2010. No agreement will be executed or work order issued without fulfillment of this condition.
