02. Eligibility / Mandatory.

- i. Valid Registration Certificate upto June-2022 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against each work;

- ii. At-least 03-works of same specifications and same nature of equivalent or more OR quantum (in terms or quantities) completed during last three years duly supported with completion certificate;
- iii. Bio data of Engineering and Technical staff working with the firm;
- iv. Annual turnover at-least twice per annum, of the estimated cost of the work applied, in last 3 years i.e 2018-19, 2019-20 and 2020-21 (turnover will be evaluated from annual returns and Audit Reports).
- v. Annual audited reports of last three years i.e 2018-19, 2019-20 and 2020-21 from (ICAP) registered audit firm;
- vi. List of Machinery and equipment available with documentary evidence of its ownership, as required under 4.2(1) as S.P.P Rule - 2010;
- vii. Certificate of Bank showing credit worthiness of at-least 20% of the estimated cost of work applied along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for 03- years i.e 2018-19, 2019 - 20 & 2021-22 and recent bank certificate must be attached showing available balance of at-least 20% of the cost;
- viii. Registration with Income Tax Department (NTN certificates) with activates status with Federal Board of Revenue;
- ix. Annual Income Tax returns of last three years i.e 2018-19, 2019-20 & 2020-21;
- x. Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate (with active status).

04. Bidding / Tender Documents.

- i) Contract documents and other terms and conditions can be seen and issued from office of the undersigned on payment of tender fees shown against work or can be downloaded from the official website of SPPRA i.e "ppms.pprasingh.gov.pk". The bid security mentioned above in the shape of call deposit only from any scheduled bank of Pakistan in favour of the Executive Engineer, Highway Division Karachi, showing on account of (Name of firm) should be attached with the Tenders, otherwise such tenders will not be entertained;
- ii) As per S.P.P Rules, (Ammended-2021), a bid after meeting the eligibility bidder on the basis of cost; called as "Most Advantageous Bid"
- iii) The tender will be opened in presence of the Procurement Committee / participating contractors / firms and their authorized representatives, who may wish to be present;
- iv) The CD-R's of the technically responsive bidders but rejected due to higher rate will be returned back after the issuance of work order to the successful bidder;
- v) In case of any member of procurement committee happens to be out of Head Quarter or in a meeting on the date of opening, bids will be submitted and opened on next working day on same schedule;
- vi) Joint Venture will not be allowed;
- vii) Fresh affidavit with effect that all the documents / particulars / machinery information furnished is true and correct. In case of Bogus / Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage;
- viii) Details of owner alongwith CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner;
- ix) In case of Firm, giving full particulars of Directors / Proprietors or other connected information along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished;

- x) Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work awarded to him;
- xi) Affidavit to this effect that the Firm / Contractor have not been black listed previously by any executing agency;
- xii) The Tenders should be submitted alongwith the above required documentation / Information, if such lack the tender will not be considered by the procurement committee and no excuse will be entertained.
