- Documentary evidence showing the contractor/firm owns/Rented related works.
- Bio data of Engineering and Technical staff working with the firm.
- Current Affidavit/undertaking regarding firm neither been black listed nor involved in any court case/Litigation with and Government Department.
- Affidavit that the given information documents and data is absolutely true and correct.
- A Mandatory check list of documents to be submitted by the bidders is placed in the Bidding Document which must be filled by the bidder.
