The bidding documents will be issued to the interested firms/contractors on submission of written request on original letter head on payment of non-refundable cost of tender price mentioned against each work, through call deposit/pay order on any scheduled bank in favor of **Karachi Development Authority** and bidding document can also be downloaded from the SPPRA website (<https://ppms.pprasindh.gov.pk/PPMS/>) with tender fee amounting to Rs 5000/-.
 4. The bid security equal **5%** of Bid Amount in shape of pay order from any scheduled bank in favor of **Karachi Development Authority** must be enclosed with tender documents; otherwise the tender will be rejected.
 5. That Bidder who shall fulfill the entire Eligibility Criteria or Mandatory requirement shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation; otherwise the tender will be declared as non-responsive / rejected.
 6. The contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures incomplete / conditional tenders will be not accepted.
 7. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
 8. In case, the date of opening declared as a public holiday by the Government, or non-working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
 9. The procuring agency may reject all or any bids/tenders at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules 2010 (amended time to time).
 10. Tenders will not be received after the schedule time.
 11. All corrections / over writings shall be clearly Re-written with Initials and duly stamped by the Bidder.
 12. All clauses of Eligibility Criteria or Mandatory criteria mentioned in tender/bidding documents have same priority and non fulfillment of any of clause shall lead to bid rejection/disqualification
