- i) Valid Registration with Pakistan Engineering Council (PEC) for the year 2023.
- ii) The firm should have following specialized codes: CE09, CE10 and EE11 (General Electrical Works only)
- iii) Successful experience in the execution of at least 02 (two) projects of similar nature and complexity amounting successfully completed in last 5 years amounting to at least 50% of the Estimated Cost. The Performance Certificate must be attached.
- iv) Successful experience in the execution of at least 01 (one) project in similar site / geographical condition successfully completed in last 5 years. The Performance Certificate must be attached.
- v) The contractor must have Batching Plant, Transit Mixer, Concrete Pump and Scaffoldings available with documentary evidence of its ownership/rental/leased for the Project (the machinery / equipment may be physically verified by the committee)
- vi) Average Annual Financial turnover not less than the estimated cost for the last five years with Audit Report certified by ICAP registered Audit Firm.
- vii)Bio data of Engineering and Technical staff working with the firm along with attested CVs and salary slips also showing employment with the firm (last 6 months). Civil & Electrical Engineers employment with the firm along with same reflected in PEC License.
- viii) The contractor must have following Personnel Capabilities:

For Key Positions (Academic Qualifications):

- a. At least 02 Civil Engineers having B.E (Civil) degree
- b.At least 01 Electrical Engineer having B.E (Electrical) degree.
- For Key Positions (Experience):
 - a. Worked in at least 2 or more similar projects
 - b. Must have experience of 5 to 10 years
- ix) Financial Statement (Summary) and income tax returns for the last 03 years
- x) The bid security in the form of Pay Order or Deposit at Call or Demand Draft issued by a scheduled bank in Pakistan.

xi) Affidavit on non-judicial paper that the firm has not been involved in any litigation / arbitration cases in verses any executing agency in any court of law OR if involved the details must be provided in the same.

ix) Affidavit on non-judicial paper that firm has never been black-listed from any executing agency.x) Must have 20% tender bidding amount in bank to show financial capability (Current Account Balance Slip of Company / Firm Bank must be attached)

xi) Registration with Income Tax, Sindh Revenue Board SRB (NTN Certificates) and copy of CNIC.
