Tender comprising of Technical Proposal and Financial Proposals must be submitted in separate sealed envelopes with clear marking of "TECHNICAL PROPOSAL" AND " FINANCIAL PROPOSAL" & will be received back on **04/10/2022** upto 09.30 A.M from the issuing office. Technical proposal of the participating firms will be opened on the same day at 10.00 A.M by the Tender opening committee in presence of participating contractors/firms of their authorized representatives who wish to be present.
3. Interested Bidders can also download bidding documents from the official website of SPPRA "ppms.pprasinhd.gov.pk/PPMS/public/" and submitted along with prescribed tender fee (Non Refundable) in shape of pay order. The bidders are advised to visit the Site before submission of the bid document.

4. **The TECHNICAL PROPOSAL** opened shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened and publicly announced on the date and time that will be communicated in writing to all the qualified contractors / firms in advance, Financial bid / proposal of Technically un-qualified contractors shall be returned to them Un-opened.
5. Tenders shall be carefully & neatly filed and signed by the bidders. Each bid must accompany the Earnest Money as mentioned below in the shape of Call Deposit in favour of Executive Engineer PHE Division JAMSHORO. 5% Bid Security shall be submitted with technical proposal. Incomplete tender overwriting or conditional tender shall not be entertained.

ELIGIBILITY

1. Bid Security not less than 5% of estimated cost in the shape of Call Deposit / Pay Order / Demand Draft / Bank Guarantee must be accompanied with "Technical Bid"
2. Bidding will be carried out under "Single Stage-Two Envelope" method of procurement. Bidders are required to be registered with Pakistan Engineering Council with valid Registration certificate with specialization in CE-09 CE-10, valid for the year 2022-23.
3. Registration with Income Tax Department (NTN certificate) with active status with Federal Board of Revenue.
4. Registration Certificate of Sindh Revenue Board Government of Sindh STN certificate.
5. Affidavit on non judicial paper to the effect firm / company has never been black listed previously by any Executing Agency

6. **(QUALIFICATION CRITERIA)**

Technical proposal must contain Company Profile with following information,

- Bank Statement of last Six Months with financial capability must have turnover to equal the offered cost
- Complete bio data viz Qualification and experience of technical staff and key site management personnel working with the firm with Documentary Evidence.
- List of completed works (at least 3 Nos) of Water & Sewerage with documentary evidence along with satisfactory completion certificate of last three years.
- Details of machinery and equipment available by the firm for execution of work with documentary evidence.
- List of works in hand (along with copy of work order issued) and financial worth of the company / contractor indicating the financial capacity to handle the works


TERMS & CONDITIONS

Under the following conditions bid will be rejected -

- Conditional Tenders;
- In case of force majeure on submission / opened date and time or if Government declares Holidays, the tender shall be submitted / opened on the next working day at the same time and venue.
- Bid not accompanied by bid security of required amount & form as above;
- Bid received after specified date and time
- The bidders providing unsubstantiated and/or incorrect information are liable to be disqualified and for legal action. Procuring agency has to reject such in the light of clause 11.3.4 (amended 2019)
- Black listed firms.
- A Firm to be rejected if there is any officer of department intimated about the shortage of any material / work.
