- i) Valid Registration Certificate upto date and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against each work.
- ii) Atleast 03 works of same specifications and nature of equivalent or more cost completed during past three years, duly supported with **Completion Certificate (Works/BER with SPPRA ID)**.
- iii) Bio data of Engineering and Technical staff working with the firm (Engineer(s) Registered with PEC).
- iv) Annual turnover atleast twice per annum, the estimated cost of the work applied, in last 3 years.
- v) Annual audited reports of last three years from registered audit firm.
- vi) List of Machinery and equipment available with documentary evidence of its ownership (Power of Attorney).
- vii) Certificate of Bank showing credit worthiness of atleast 10% of the estimated cost of work applied along with Bank Statement.
- viii) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- ix) Annual Income Tax returns of last three years.
- x) Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last 3 years.

5. Affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus /Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
6. Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner for participation.
7. In case of Firm, give full particulars of Directors / Proprietors or other connected documents along with Power of Attorney, in case of being sole proprietors such undertaking on Affidavit be furnished.
8. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work of any Government Department / organization.
9. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
