- i) Method of Procurement: <u>Single Stage Two-Envelope</u> Procedure (must contain two separate Sealed Envelopes with Signed & Stamp of Firm for <u>"Technical Proposal"</u> & <u>"Financial Proposal"</u> otherwise such tender will not be entertained).
- **ii) <u>Financial Proposal</u>** will be opened (as per SPPRA Rule) for those firms only who qualify the mandatory requirements in Technical Proposal.
- iii) Bidder should be registered with Pakistan Engineering Council (PEC) in relevant category with specialization in BCO2, CE09, CE10, CE11 & ME03 supported by PEC valid registration certificate.
- iv) In case of works costing below Rs.4.00 (M) the conditions at S.No.(iii) will not be applicable.
- v) Bio data of Engineering and Technical staff (Civil & Electrical Graduates) working with the firm along with Attested CVs and their Income Tax Deduction which showing employment with the firm.

- d) Litigation history in which the decision has been given against or in favor of the firm (s). List and give brief details of arbitration / litigation / court cases if any in case of no such cases enclose an affidavit that the firm has not been involved in any litigation arbitration with any Government Departments.
- e) Electrical Works carried out during the last Three (3) years by the contractor/ associates/ subcontractor. The list of works must be submitted with the tender documents including work order.
- f) Bank Account Statement in the name of the Bidders Firm for the last three (3) years must be submitted with the tender documents.
- g) Copy of valid Electrical License in the name of Firm / associates / sub-contractor renewed up to date from Electrical Inspector -Government of Sindh, must be submitted with the tender documents.
- **h)** Annual audited reports of last three years from (ICAP) registered audit firm. Audit report issued other than (ICAP) registered audit firms will not be accepted.
