## **NOTICE INVITING TENDER**

Procuring Agency invites sealed bids in single stage two envelope methods from all the interested bidders under SPPRA rules 2010 for the following works who meet the following qualification criteria:

- i. Annual Turnover Equal to the Estimated Cost of Work for Three Years.
- ii. Active registration with income tax department and income tax return for last 2 years.
- iii. Electrical License (For Electric Works) is required.
- iv. List of litigation (if any) and nature of litigation and affidavit that the firm has never been black listed.
- v. Active registration with Sindh Revenue Board, Sales Tax Registration Certificate must be attached.
- vi. NTN and CNIC are required.
- vii. The "bids will be received back on same day up to 12:30 pm. The envelope containing "Technical Proposal" as per required above documents (original) will be opened on the same day in presence of procurement committee and the bidders of their authorized representative who wish to present on the occasion 2<sup>nd</sup> envelope containing Financial Proposal of Technical qualified bidders will be opened later, the date will be communicated after completion of evaluation of technical proposal Each bid must accompany earnest money as mentioned already in shape of call deposit in favour of Executive Engineer Minorities Affairs Sindh shall be submitted with Technical proposal. Incomplete bid, over writing or conditional bid / tender shall not be entertained.

The tender documents should accompany the 5% earnest money of the estimated cost mentioned in the list in the shape of pay order or call deposit form any of the scheduled Banks daily pledged to the undersigned.

Blank tender documents can be obtained from the date of Publication Camp Office Barrack No.17 Block-4A, Sindh Secretariat, Karachi, on payment of cost of tender (not refundable) viz pay order as mentioned in the list on any working day up to 22-03-2023 up to 05:00(P.M) The same will be received back in sealed envelope up to 23-03-2023 up to 12:30(P.M) and the same will be opened on the same day at 01:00(P.M) in presence of the intending contractors or their authorized representative who may like to be present. The un-responded tenders will be issued up to 05-04-2023 at 05:00(P.M) and same would be received back on 06-04-2023 up to 10:00(A.M) and will be opened at 10.30(A.M) respectively in same manners.

Contractors are bound to quote workable rates, failing which they will be blacklisted in future tendering.

The conditional tenders will not be accepted and the Procuring Agency may reject all or any bids subject to the relevant provisions of the SPPRA Rules.

The successful contractors whose tenders are accepted will have to obtain adhesive stamps from Assistant Superintendent Stamps, Government of Sindh, and Karachi on payment of Stamps fees according to schedule prescribed in the Sixth Finance Act 1996 amended rule 2015 and signed the agreement.
