NOTICE INVITING TENDER

Minorities Affairs Department invites sealed bids in **Single Stage Two Envelope Methods** from all the interested bidders under SPPRA rules 2010 for the following works who meet the following qualification criteria, terms and conditions:-

- i. At least two works of similar nature with equivalent or more cost under taken in last 3 years along with Completion Certificate of Respective Department showing total cost of works along-with coloured photographs (at least 4 photographs)
- ii. Bank statement showing current balance at least 20% of applied work(s)
- iii. List of litigation (if any) and nature of litigation and affidavit that the firm has not been black listed in any government agency and public sector.
- iv. Electrical License (For Electric Works) in Case of Electrical Works.
- v. Active registration with NTN / Sindh Revenue Board, Sales Tax Registration Certificate must be attached and CNIC are required.
- vi. PEC license for the works (where applicable)
- vii. In case Government announces public holiday or due to unavoidable circumstances in bid submission / opening day then the bids will be submitted / received / opened on next official working day at same time and venue.
- viii. The "bids will be received back on same day up to 09:30 am. The envelope containing "Technical Proposal" (serial numbers must be mentioned of applied works on the envelope of T.P) as per required above documents (original) will be opened on the same day in presence of procurement committee and the bidders of their authorized representative who wish to present on the occasion 2nd envelope containing Financial Proposal of Technically qualified bidders will be opened later, the date will be communicated after completion of evaluation of technical proposal **Each bid must accompany earnest money as mentioned already in shape of call deposit in favour of Executive Engineer, Minorities Affairs Sindh** shall be submitted with Technical proposal. Incomplete bid, over writing or conditional bid / tender shall not be entertained.
- ix. Under the following conditions, the bid will be rejected.
 - a) Conditional bids
 - b) Bids not accompanied by bid security of required amount
 - c) Bids received after specified date and time
 - d) Bids submitted by the black listed firms.
 - e) Incomplete bids as per instructions given in bidding documents
 - f) Bids without seal and stamp.

The tender documents should accompany the **5%** earnest money of the estimated cost mentioned in the list in the shape of pay order or call deposit form any of the scheduled Banks daily pledged to the undersigned.

Blank tender documents can be obtained from the date of Publication from office Barrack No.17 Block-4A, Sindh Secretariat, Karachi, on payment of cost of tender (not refundable) viz pay order as mentioned in the list on any working day up to 25-04-2023 up to 10:00(A.M) or also downloaded from the website:-<https://ppms.pprasindh.gov.pk/> and the same will be received back in sealed envelope up to 26-04-2023 up to 09:30(A.M) and the same will be opened on the same day at 10:00(A.M) in presence of the intending contractors or their authorized representative who may like to be present. The un-responded tenders will be issued up to 11-05-2023 at 05:00(P.M) and same would be received back on 12-05-2023 up to 09:30(A.M) and will be opened at 10:00(A.M) respectively in same manners.

Contractors are bound to quote workable rates, failing which they will be blacklisted in future tendering.

The conditional tenders will not be accepted and the Procuring Agency may reject all or any bids subject to the relevant provisions of the SPPRA Rules.

The successful contractors whose tenders are accepted will have to obtain adhesive stamps from Assistant Superintendent Stamps, Government of Sindh, and Karachi on payment of Stamps fees according to schedule prescribed in the Sixth Finance Act 1996 amended rule 2015 and signed the agreement.
