02. Eligibility / Mandatory.

- Valid Registration Certificate upto June-2023 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against work;
- At least 02-works of same specifications and same nature of equivalent or more cost completed during past three years, duly supported with completion certificates;
- Bio data of Engineering and Technical staff working with the firm;
- Annual turnover at-least twice per annum, of the estimated cost of the work applied, in last 3 years (turnover will be evaluated from annual returns and Audit Reports);
- Annual audited reports of last three years from (ICAP) registered audit firm;
- List of Machinery and equipment available with documentary evidence of its ownership.
- Certificate of Bank showing credit worthiness of at-least 25% of the estimated cost of work applied along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for three years and recent bank certificate must be attached showing available balance of at-least 25% of the cost;
- Registration with Income Tax Department (NTN certificates) having active status with Federal Board of Revenue;
- Annual Income Tax returns of last three years;
- Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate (with Active Status).

03. S.P.P Rule No.2 (x)-ii. Evaluated as the highest ranked bid or proposal on the basis of cost; called as "**Most Advantageous Bid**".
04. Method of Procurement; **Single Stage-Two envelop Procedure** (*As per S.P.P Rule No.46 (2).*)
- i). Bid must contain 02-separate sealed envelopes for **Technical & Financial**, otherwise such tender will not be entertained;
- ii). Unsigned and blank tender documents will be treated as **REJECTED**;
05. **Bidding / Tender Documents.**
- i) Contract documents, other terms and other conditions can be seen or downloaded from office of the official website of SPPRA i.e. "ppms.pprasinidh.gov.pk". The bid security mentioned in the shape of **call deposit** only from any scheduled bank of Pakistan in favour of **Executive Engineer, Highway Division Karachi**, on account of (Name of Firm) should be attached (in-original) with the technical bid / tender, otherwise such tender will not be entertained.
- ii) Manner of bid security other than CD-R will not be accepted.
- iii) Evaluation criteria, sub-criteria, for the evaluation of full Technical Proposal is based on Yes/No or Pass / Fail, if a bidder fails to obtain yes or pass any criteria or sub-criteria than he/it shall not be qualified.
- iv) The tender will be opened in presence of the Procurement Committee / participating contractors / firms and their authorized representatives, who may wish to be present;
- v) The CD-R's of the technically responsive bidders but rejected due to higher rate will be returned back after the issuance of work order to the successful bidder;
- vi) Joint Venture will not be allowed;
- vii) Affidavit with effect that all the documents / particulars / machinery information furnished is true and correct. In case of Bogus / Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage;
- viii) Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner;
- ix) In case of Firm, giving full particulars of Directors / Proprietors or other connected information along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished;
- x) Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work awarded to him;
- xi) Affidavit to this effect that the Firm / Contractor have not been black listed previously by any executing agency;
- xii) The Tenders should be submitted along with the above required documentation / Information, otherwise the tender will not be considered by the procurement committee and no excuse will be entertained
