5. **Deadline for obtaining bid documents** – from date of publishing this NIT in newspapers or hoisting on websites up to 20th May 2024 till 1200 hrs.





- 6. Deadline for submission of bids On 20th May 2024 till 1430 hrs.
- 7. **Opening of bids** Same day i.e., on 20th May 2024 at 1500 hrs., in presence of Procurement Committee and representatives of the bidders (who choose to attend the meeting) at below mentioned address:

- 8. If tender opening day is a government announced holiday, then it will be opened on the very next working day.
- 9. **Bid Security** All bids must be accompanied with a Bid Security equivalent to 2% of total bid price (as pay order / demand draft / bank guarantee) in favor of Inspector General of Police, Sindh and its original copy shall be submitted within envelopes marked "Financial Proposal (original) and its copy within envelop marked "Financial Proposal (copy)."
- 10. **Cancellation of Bidding Process** Police Department, GoS can cancel the bidding process any time prior to acceptance of a bid or proposal as described by Rule 25 of SPP Rules 2010.
- 11. Conditional tenders shall be rejected.
- 12. Police Department, GoS reserves the right to increase or decrease the scope of works, and/or number of vehicles (for which services are required) without assigning any reason.
