The envelope containing "Technical Proposal" (serial numbers must be mentioned of applied works on the envelope of T.P) as per required above documents (original) will be opened on the same day in presence of procurement committee and the bidders of their authorized representative who wish to present on the occasion 2nd envelope containing Financial Proposal of Technically qualified bidders will be opened later, the date will be communicated after completion of evaluation of technical proposal **Each bid must accompany earnest money as mentioned already in shape of call deposit in favour of Executive Engineer, Minorities Affairs Sindh** shall be submitted with Technical proposal. Incomplete bid, over writing or conditional bid / tender shall not be entertained.
- vii. Under the following conditions, the bid will be rejected.
 - a) Conditional bids
 - b) Bids not accompanied by bid security of required amount
 - c) Bids received after specified date and time
 - d) Bids submitted by the black listed firms.
 - e) Incomplete bids as per instructions given in bidding documents
 - f) Bids without seal and stamp.

The tender documents should accompany the 5% earnest money of the estimated cost mentioned in the list in the shape of pay order or call deposit form any of the scheduled Banks daily pledged to the undersigned.
