- iv) Annual turnover of at least last three years.
- v) Annual audited reports of last year from registered audit firm.
- vi) Certificate of Bank showing credit worthiness of atleast 10% of the estimated cost of work applied along with Bank Statement.
- vii) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- viii) Annual Income Tax returns of last year.
- ix) Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last year.

- 3. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening, bids will be submitted and opened on next working day on same schedule.
