2. Eligibility / Mandatory.

- i). Valid Registration Certificate upto June 2023 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against each work.
- ii). At least 03 works having same specifications and same nature having equal or more cost OR quantum (in terms of quantities) completed during past three years in duly supported with completion certificate, certified copies of Detailed Working Estimate and SPPRA ID's showing Bid evaluation report.
- iii). Bio data of Engineering and Technical staff working with the firm alongwith membership of PEC and upto date Driving License and detail of all current salary bank statements / firm's receipt.
- iv). Annual turnover at-least twice per annum, to the estimated cost of the work applied, in last 3 years (turnover will be evaluated from annual returns and Audit Reports).
- v). Annual audited reports of last three years from (ICAP) registered audit firm. Audit report issued other than (ICAP) registered audit firms will not be accepted.
- vi). List of Machinery and equipment available with documentary evidence of its ownership / rented with fitness certificate from concerned department and completion of all vehicle taxes paid.
- vii). List of Technical staff for Lab Testing and detail of Lab Equipments for testing of strength of Paver Blocks, RCC / CC Structures / Road Items from approved Laboratory.
- viii). Certificate of Bank showing credit worthiness of at-least 20% (average balance per year for the last 3 years) of the estimated cost of work along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for last three years and recent bank certificate must be attached showing available balance.
- ix). Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- x). Annual Income Tax returns of last three years.

- xi). Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate paid upto last 3 months (with Active Status).
- xii). Each page of the technical proposal must be numbered and attested by the owner of firm / company along with its stamp.
- xiii). Signature of participant alongwith CNIC on attendance sheet is necessary.
- xiv). In case of works costing below then 4.000 Million the conditions at Sr. No. (i) will not be applicable.

4. Bidding / Tender Documents

1. Contract documents and other terms and conditions can be seen or downloaded from the official website of SPPRA i.e "https://ppms.ppr.sindh.gov.pk/PPMS/". The tenders fee amount to PK Rs. 3000/- and the bid security mentioned above **in the shape of Call Deposit only from any scheduled bank of Pakistan in favour of the Executive Engineer, Highway Division Sanghar, on account of (Name of Firm)** should be attached with the Technical Bid / Tenders, otherwise such tenders will not be entertained.
2. Evaluation Criteria, sub-criteria, for the evaluation of Full Technical Proposals is based on **Yes / No** OR **Pass / Fail**; if a bidder fails to obtain yes or pass in any criteria or sub-criteria then he / it shall not be qualified.
3. The tender will be opened in the presence of the Procurement Committee / Participating Contractors / Firms and their authorized representatives, who may wish to be present.
4. Bid shall comprise **Single Package containing Two separate Envelops**. Each envelop contain separately the **Financial Proposal** and the **Technical Proposal**. Envelop shall be marked Technical proposal and Financial Proposal in bold and legible letters to avoid confusion.
5. **TECHNICAL PROPOSAL** opened, shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bids / proposals of technically non responsive shall be returned to the respective bidders un-opened.
6. The CD-R's of the technically responsive bidders but reject due to higher rate will be returned back after the issuance of work order to the successful bidder.
7. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening bids will be submitted and opened on next working day on same schedule.
8. Joint Venture will not be allowed.
9. Fresh affidavit with effect that all the documents / particulars / machinery information furnished is true and correct. In case of Bogus / Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
10. Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on **Judicial Stamp Paper** from owner.
11. In case of Firm, giving full particulars of Directors / Proprietors or other connected along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished.
12. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work.
13. Fresh affidavit to this effect that the Firm / Contractor have not been black listed previously by any executing agency.
