- The bidding documents will be issued to the interested Firms/Contractors on submission of written request on letter head and on payment of non-refundable cost of tender price mentioned against each work, through pay order from any scheduled Bank in favor of TMC Saddar Karachi, and bidding documents can also be downloaded from the SPPRA Website (www.pprasindh.gov.pk) with tender fee mentioned as above by mail or by hand.
- The Bid Security equal to 5% of tender amount (Schedule Rate plus Open Rate) in shape of pay order from any scheduled Bank on company/ firm account in favour of TMC Saddar Karachi must be enclosed with tender / bid documents otherwise the tender will be rejected.
- The intrusted contractors / proprietor will be showed / provided original current NIC, NTN certificate, SRB, valid electric license.
- The Contractors must have to mention their complete and correct present/ postal address in tender documents and quote the rates both in-words and in-figures. Incomplete / Conditional tenders will be not accepted.
- If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
- Canvassing in connection of tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for rejection.
 - All the tenders will be dropped on as per above Schedule up to 9:30 am and will be opened by the Procurement Committee, in the office of the S.E Office, TMC Saddar M&E Office Karachi. At 10:00 am in presence of the Contractors/Parties/Firms/Bidders who wish to be present.
