- The Procuring agency may reject all or any bids / tenders at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules.

- d. Annual audited reports of last three years from (ICAP) registered audit firm. Audit report issued other than (ICAP) registered audit firms will not be accepted.
- e. Valid registration with Federal Board of Revenue (FBR) and Annual Income Tax returns of last three years.
- f. Valid Registration with Sindh Revenue Board (SRB)
- g. The Bid Security 5% (Five Percent) in the Shape of Call Deposit issued from any schedule bank of Pakistan in favour of undersigned shall be submitted at the time of submission of bidding documents.
