- Certificate of Bank showing credit worthiness of atleast 10% of the estimated cost of work applied along with Bank Statement.
- Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- Annual Income Tax returns of last year.
- Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last year.

04. Bidding / Tender Documents.

2. The tender will be opened in presence of the Procurement Committee/ participating contractors /firms and their authorized representatives.

4. Affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus /Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
5. Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner for participation.
6. In case of Firm, give full particulars of Directors / Proprietors or other connected documents along with Power of Attorney, in case of being sole proprietors such undertaking on Affidavit be furnished.
7. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work of any Government Department / organization.
8. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
9. The tenders should be submitted along-with the above required documentation / information, if such lack the tender will not be considered by the procurement committee and no excuse will be considered.
