- iv) Annual turnover of last year.
- v) Annual audited reports of last year from registered audit firm.
- vi) Certificate of Bank showing credit worthiness of atleast 10% of the estimated cost of work applied along with Bank Statement.
- vii) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- viii) Annual Income Tax returns of last year.
- ix) Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last year.

- 7. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work of any Government Department / organization.
- 8. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
- 9. The tenders should be submitted along-with the above required documentation / information, if such lack the tender will not be considered by the procurement committee and no excuse will be considered.
