i- Valid / Renewed Pakistan Engineering Councils license / Registration for the year 2020-2021 (N/A).

b) **MINIMUM QUALIFICATION CRITERIA.**

i- Registered with relevant Tax authorities (Income Tax / Sales Tax) (where applicable.)

ii- Registered with Sindh Revenue Board.

iii- Bank Statement of last 03 years.

iv- Turnover and experience at least 03 years in the relevant field.

v- A firm is not Black listed / Debarred by any Procuring Agency otherwise the D.M.C East will disqualified the firm subject to Rule -30 of Sindh Public Procurement Rules-2010 (amended 2017) affidavit tht the firm is not black listed is required.

vi- Any other factor deemed to be relevant by the DMC East, subject to the Provision of Rule-44.

vii- Each bid shall comprise One Single Envelop containing the financial proposal and required information as mentioned in Bidding documents.

viii- All the received bid shall be opened and evaluated as prescribed in the Notice Inviting Tenders or Bidding documents.

ix- Original paid up challan of professional Tax for the year 2020-2021 is required.

x- Proof of machinery owned leased is required.
