- ii) Atleast 03 works of same specifications and nature of equivalent or more cost completed during past three years, duly supported with Completion Certificate.
- iii) Bio data of Engineering and Technical staff working with the firm (Engineer(s) Registered with PEC).
- iv) Annual turnover of last year.
- v) Annual audited reports of last year from registered audit firm.
- vi) Certificate of Bank showing credit worthiness of atleast 10% of the estimated cost of work applied along with Bank Statement.
- vii) Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- viii) Annual Income Tax returns of last year.
- ix) Valid Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate & returns of last year.

04. Bidding / Tender Documents.

1. Contract documents and other terms and conditions can be seen and blank tenders purchase on cash payment or through pay order of Rs.5000/- or can be downloaded from the official website of SPPRA. The **bid security @ 5%** as mentioned against each work **in the shape of call deposit only from any scheduled bank of Pakistan in favour of the Executive Engineer, Local Government Projects** should be attached with the Bid / Tenders, otherwise such tenders will not be entertained.
2. The tender will be opened in presence of the Procurement Committee/ participating contractors /firms and their authorized representatives.
3. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening, bids will be submitted and opened on next working day on same schedule.
4. Affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus /Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
5. Details of owner along with CNIC on Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner for participation.
6. In case of Firm, give full particulars of Directors / Proprietors or other connected documents along with Power of Attorney, in case of being sole proprietors such undertaking on Affidavit be furnished.
7. Undertaking on stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work of any Government Department / organization.

8. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
9. The tenders should be submitted along-with the above required documentation / information, if such lack the tender will not be considered by the procurement committee and no excuse will be considered.
